It was agreed that the Clerk and Chairman as k G Whitfield whether he would be prepared to undertake the audit for 2012/2013.

Cllrs Mallett and Johnson completed their Declaration of Acceptance of Office

The Chairman reported upon additional items for consideration which the chairman deems urgent by virtue of the special circumstances to now specified.

318/12 Confirmation of minutes

RESOLVED – that the minutes of the meeting held on the 20^{th} March 2012 were correctly recorded and that they be signed as being a true record.

319/12 Matters Arising

- a) Parish Youth Plan Further to minute 305/12(a) the Chairman reported that details had been submitted to $\triangle CRE$
- b) Community Centre Disabled car parking Further to minute 305/12(c). The works had been completed except the markings.
- c) Queens Diamond Jubilee Further to minute 305/12(d) The Clerk reported that a budget had been received in the sum of £1,211 and to date income of £1,150 secured. The Council accepted the figures and agreed that a float of £700 be given to the Committee. The Chairman agreed to supervise the spending of the float.
- d) FACT Further to minute 309/12(b) Six members in the community that regularly use the service. One lady is wheelchair bound and uses it twice weekly to carry out errands. RESOLVED that a donation of £100 be made.
- e) Brigstock & Wrens Further to the Council's representative Karen Drewry being appointed as Clerk to the Charity, the Council need to appoint a replacement representative. RESOLVED that Cllr M Taylor be appointed.
- f) Affordable Housing Further to minute 305/12(f) the Chairman reported that he had met with Mark Deas of ACRE and they had inspected two sites. M Deas would consult with Fenland District Council and then the Parish Council and residents would be approached. Cllr Mallett reported that locals would have first priority and he was aware of four youngsters already looking for housing.
- g) Village directory Further to minute 293/12(f) The Chairman reported that the proof had been agreed and the directory would soon be circulated.

320/12 Police Matters PCSO M Bogunovic police representative report was circulated to all Councillors. He reported upon the burglaries at Newton and the main concerns were theft of scrap metal and diesel. Suspicious sightings of a white van had been reported and investigated. He stressed that it was important that all suspicious incidents be reported. The Chairman referred to a lowering of recorded incidents in Cambridgeshire which it was felt a result of the public not reporting incidents. His concern was that it may affect the number of officers employed.

Parking outside the school was still an issue and Cllr Long reported that parents were requested not to obstruct residents drive ways.

321/12 Cambridgeshire County Councillor Report Cllr S Tierney did not submit a report

322/12 Fenland District Council – Cllr Seaton reported upon the Rural Capital Grant and was aware that Tydd St Giles had yet to submit their application. Cllr Long reported that the application was in hand. He reported upon the Rural Broad band scheme being led by Cambs CC Cllr Ian Bates.

The Fenland Core Strategy was being revised due to alterations of the rules and regulations and should soon be finalised.

The second meeting of the Boundary Commission review would take place on Tuesday 29th May.
