All sites submitted during this process will be assessed to determine if they are suitable and available for development and are deliverable during the plan period. Completed forms **must** be accompanied by a site plan on an OS base which clearly identifies the site promoted. Other helpful information, such as land in the same ownership (if known) and potential access points may also be included on the map. We will consider sites with a site area of **0.15ha or more**, or that are capable of delivering **5 or more dwellings**.

All existing sites and broad areas for growth identified in the adopted Fenland Local Plan (2014) will be reviewed. Major sites with outline planning permission will also be assessed to determine if they are suitable for allocation in the Local Plan. To assist with the site assessment process, promoters of existing sites should provide a site submission (please state the policy or planning application reference on the site suggestion form if known). This will help to ensure that information used in the assessment is up to date and will enable all sites to be considered fairly.

We will publish a Strategic Housing and Economic Land Availability Assessment (SHELAA) report in early 2020 listing all sites suggested to us. Our preferred sites will be included in the Draft Local Plan due for publication in spring/summer 2020. We will publish an evidence report explaining the reasons for the inclusion or rejection of each site alongside the Draft Local Plan.
