As part of the Local Plan Issues & Options consultation, local communities are invited to nominate sites for consideration as 'Local Green Spaces'.

Local Green Spaces are a national designation which aims to protect green areas or spaces, granting protection akin to 'Green Belt' status. If you would like to suggest a site for consideration please fill in this form and supply a map which clearly shows the area proposed for Local Green Space designation.

Alternatively, sites can be nominated for Local Green Space designation via the online questionnaire available at: www.fenland.gov.uk/newlocalplan.

All sites nominated during this process will be assessed against criteria set out in national policy. Local Green Space designation will only be used where the green space is:

- a) in reasonably close proximity to the community it serves;
- b) demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
- c) local in character and is not an extensive tract of land.

All suggested Local Green Spaces will be assessed and the preferred areas will be included in the Draft Fenland Local Plan which is expected to be published for consultation in summer 2019.


