4 **Police Matters**

Following last month's successful Speed Enforcement Checks throughout the north rural villages, further Speed Enforcement Checks were carried out during August. The aim is to help combat the speeding issues which have been reported to us. During the month of August in some of the North Rural Areas, we issued a total of 5 speeding tickets, and gave words of advice to another 3. Unfortunately, due to other work commitments, we were unable to cover all of the villages. However we will endeavour to undertake Speed Enforcement Checks, whenever time and resources allow, in order to combat the ongoing problems. Any of the villages which have not been covered during August, will be first on the list for September. As usual, we are always trying to encourage local community groups to set up their own community speed watch groups, so If you know of or have 4 or 5 volunteers that are interested in taking part, please let me know, or if you would like any further information about setting up your own speed watch group, please do not hesitate to contact me. If you have any particular road or street of major concern regarding the speeding issues, please forward the details to me via email, and I will endeavour to target those particular areas.

We continue to undertake patrols in Tydd st Giles and the surrounding areas as often as resources permit. If you have any areas of concern, please let me know.

One of our main key priorities is to attend schools either at the start or end of school times to monitor parking issues, and to integrate with the children and parents/guardians, which will recommence at the beginning of September when the children return to school.
